## 19. Macro-economic stability

The Union Finance Ministry today said India's growth is sustainable due to growing macroeconomic stability on various fronts including improved current account deficit, robust banks and easing inflation pressure. Fortune India

If one compares current situation with UPA2 then macro-instability was caused by fiscal expansion, high crude and <u>food support prices</u>, <u>2013 run on the rupee</u>, phone banking, banking sector problems, high inflation and over-leveraging.

Conversely, stability has helped India pull through the difficult years of 2019 to 2021.

## 20. Taming CPI inflation

According to this Hindustan Times chart, rate was 10.1% in 2012-13, 6.1% in 2022-23 and expected to be (as per RBI projection) 5.4% in 2024-25.

Ashok Gulati <u>wrote</u> in the *Indian Express*, "The Modi government has surely done a much better job by holding the inflation rate at 5.1 per cent vis-à-vis Manmohan Singh's period when it averaged at 8.1 per cent."

The government realized that high inflation rates and Ram Mandir cannot go hand in hand. A first is introduction of subsidized Bharat Atta and Rice.

## 21. Increase in Capital Expenditure

During Covid many said give incentives to India Inc or doles to public like President Biden did. Instead, this government has consistently focused on increasing capital outlay.

# 22. Number of Tax Returns filed

It was 33.1 million in FY14, 63.3 million in FY19, 74 million in FY23. HT says that app two third of returns filed were Nil returns and the top seven states account for 60% of the non-zero ahead.

While increase in FD and CG debt can be attributed to Covid19 there is a need to bring down the debt to GDP ratio. A high ratio makes economy vulnerable.

# 24. High Public Debt as a % of GDP

Noted economist <u>Sajjid Chinoy wrote</u> in the *Indian Express*, "Public debt to GDP is expected to increase from around 81 per cent of GDP to 83 per cent. That India's consolidated deficit is too large for peace times and will continue to weigh adversely on debt dynamics if not brought down. This is because even as the Centre was committed to reducing its fiscal deficit from 6.4 per cent of GDP last year to 5.9 per cent in 2023-24, state deficits are on course to widening (from 2.8 per cent of GDP to 3.1 per cent or even wider), such that the consolidated fiscal deficit will stay close to 9 per cent of GDP."

States have to reduce debt too. Freebies and opting for the old pension will increase debt levels.

25. IAF Orders increasing domestic production (Business Standard Sept19, 2023 editorial)

"The remaining 40 C-295 medium transport aircraft will be manufactured and assembled at Vadodra in collaboration with Tata Advanced Systems Ltd. This will galvanize the development of India's aerospace ecosystem." Not to forget orders for Tejas Mark 1 and 1A fighters.

## 26. Infrastructure

This requires labour, cement and steel, the first generates employment and others demand in core sectors of the economy. Savings in travel time reduces logistics and working capital cost. Some infrastructure projects are below. <u>Picture see link</u>

In 2021, the cumulative collections were at Rs 34,778 crore." <u>Source</u> ThePrint

With this, data from only six states—Himachal Pradesh, West Bengal, Uttarakhand, Sikkim, Nagaland and Meghalaya—and the UT of Lakshadweep remain to be digitally integrated. Once complete, Gati Shakti will save time and costs on project implementation, as it provides easy data access to stakeholders."

Its success or failure will be known in due course but a serious attempt is made to reduce trade deficit with China.

## 40. Making Railway Wheels Locally

India imports all Railway Wheels from China. Recently, Titagarh Rail Systems and Ramakrishna Forgings set up a joint venture to set up Asia's largest train wheel manufacturing plant. It will take three years to make in India. <u>Source</u>

## 41. Hits and Misses over 10 years- BS editorial Jan 31, 2024

1. Implemented Insolvency and Bankruptcy Code. 2. Merger of public sector banks and their recapitalization, helped address the twin balance-sheet problem. 3. GST. Tax system after years shows signs of stabilization and increased revenue. 4. Real Estate (Regulation and Development Act), Decriminalising minor offences, liberalizing FDI in various sectors and adopting flexible inflation targeting.

## Misses

1. Public debt at well over 80% of gross domestic product is always a source of macroeconomic vulnerability for a country like India. 2. Higher debt and interest payments are also affecting government spending. 3. The government needs to reduce fiscal deficit at a faster pace to bring down public debt.

## 42. Railway Electrification

Railways were one of the biggest consumers of diesel. This adds to India's import bill.

According to the <u>Railways site</u>, 'The pace of electrification has gathered momentum in the last few years as since 2014, a record 37,011 RKM has been electrified against electrification of 3,874 RKM during 2007-14. Remarkably, out of the total 58,812 RKM electrified so far on pan India basis 50% has been electrified only during the last five years. Indian Railways electrified 58,812 Route Kilometers (RKMs) till March 31, 2023 which is about 90% of the total broad-gauge network (65,300 RKMs) of Indian Railways."

# 43. Promoting Start-Ups

Ashok Gulati wrote, "It may also be noted that the Modi government has focused on fostering entrepreneurship and empowering youth to become job creators. The Startup India program has been instrumental in this regard, leading to a remarkable increase in the number of recognised start-ups-they have witnessed a 100-fold jump since 2016."

According to a <u>PIB release</u> dated 7/12/22, "The number of recognized Startups increased from 452 in 2016 to 84,012 in 2022 (as on 30th November 2022)."

# 44. Privatization of Air-India

This is a major achievement because Air India was bleeding. In fact, to make the deal attractive for the Tatas the government had to take over app Rs 61,000 crs of Air India debt and liabilities. <u>Economic Times</u>

Where this government is at fault that it has not taken action against those responsible for bring AI to this pitiable state.

#### 45. Merger of smaller PSU Banks with bigger ones

In 2020 Andhra and Corporation Banks were merged with Union Bank. Also, Allahabad bank was merged with Indian Bank. Dena and Vijaya Bank were merged with Bank of Baroda with effect from April 1, 2019. Oriental Bank of Commerce and United Bank of India were merged with Punjab National Bank (PNB) w.e.f. 1/4/2020. Syndicate Bank merged with Canara Bank.

#### 46. Converting ordinance factories into companies.

#### 47. Highest medal tally at Asian Games 2023 in over 60 years

India won over 100 medals. "India's previous best performance at the continental showpiece event was in Jakarta five years ago, with 70 medals. Its previous highest overall finish was at the 1962 Asian Games, also in Jakarta, when India finished third. In every edition since then, the Indian team has ranked fifth or lower." #### 48. Rise in number of Airports

In her Budget 2024 speech Ms Sitharaman said that in the last 10 years the number of airports has doubled to 149. <u>Source</u> According to a PIB <u>circular</u> <u>dated 23/4/23</u>, "The number of operational airports in the country has doubled from 74 in 2014 to 148 in 2023."

## 50. Introduction of New Educational Policy (NEP)

According to this June 2023 *Indian Express* report the hits are, "The NEP 2020 is a policy document outlining a series of reforms to be pursued in education, the National Curriculum Framework (NCF), a crucial policy document for revising textbooks and classroom pedagogy, is nearly complete, Presently, the UGC is giving final touches to a regulation that would allow foreign universities to establish campuses in India that have their own admission process, the freedom to determine fee structures and recruit faculty and staff from here and abroad. In addition to the new centrally-run educational institutions (including 7 IITs, 7 IIMs, 16 IIITs, 15 AIIMS of which 12 are partially or fully functional) set up in the last nine years, there was a significant capacity enhancement of existing institutions by way of the EWS quota."

Increase in female participation – "For instance, the supernumerary seats were introduced for women at IITs and NITs in 2018, resulted in a rise in female representation from 9% in 2017 to 20% in 2022 at IITs over five years. Additionally, in 2021, all 33 Sainik Schools transitioned from being all-male to admitting girl cadets, following a successful pilot in 2018."

"In a bid to end "inspector raj" and dismantle lobbies, the country's apex medical education body, the Medical Commission of India, was dissolved in September 2020 and replaced with a new body-National Medical Commission."

According to <u>Outlook</u>, "There has been a 69-per cent increase in the number of medical colleges in the country, from 387 before 2014 to 654 as of now, the government informed Parliament on Tuesday. Further, there has been a 94-per cent rise in the number of MBBS seats, from 51,348 to 99,763."

A 500 ml bottle of nano urea is equivalent to a 45 kg bag of conventional urea. The efficiency of nano urea is more than 80 per cent as compared to around 40 per cent of conventional urea. It increases yield by 3-16 per cent and additional income for farmers is estimated around Rs 2400/- to 5700/- per acre. Its use causes less soil, water and air pollution."

# **19.** The government failed to make a strong case publicly for shifting agriculture from the State to Concurrent List.

In 1950 (when Constitution adopted), there was no fertilizer and farm insurance subsidy, no PM Kisan, minimum support price and buffer food stocks. It was assumed then that States would incur all agriculture related expenditure (hence given right to tax agri income) but things have changed.

The Centre could, in consultation with States, set up the equivalent of a GST Council to agree on a framework for bringing agriculture under the Concurrent List.
